

### **Annual Membership Meeting Set Aside**

# **Living Among Alligators**

There have been discussion several threads on Gulf Hills Living this year concerning alligators in Gulf Hills bayous. In case you have not thought about the situation, Gulf Hills was developed with the alligator's natural habitat. Just as any other potential hazard

of nature, please be aware of their presence and keep your distance. Never encourage contact with humans on land by feeding alligators. If one has taken to staying in your area, it would be advisable not to put fish scraps into the bayou. We have been advised that alligators are naturally hesitant to come close to humans but are naturally curious and will watch from a distance.

If the situation becomes increasingly hazardous with a particular alligator, our state wildlife officials have a way to deal with the individual alligator. However, this situation should be observed and specific details be given to officials so they can deal with the alligator appropriately.

## **Automobile Speeding Issues**

Gulf Hills Civic Association Director, Haley Chatham, has been tasked with leading a committee focused on the issues of



automobile speeding on our Gulf Hills roads. This focused group will be comprised of Gulf Hills Civic Association Members that are willing to gather data on the speeding problem, brainstorm ideas for mitigation, then bring suggestions to our Jackson County officials. Haley has a big task ahead that will not be completed in a short time or with a quick fix. The first effort of this group will be to gather information on where and how often does speeding, running stop signs, lane encroachment, etc. occur. Your help as daily observers will be appreciated.

So that we are all grounded on at least one fact, the speed limit is 25 MPH in Gulf Hills, except when otherwise posted. Shore Drive and Ridge Road are 25 MPH. Many of our narrow, side roads are posted at 15 MPH. Please take notice and into account that we are a residential neighborhood. We also use our roads to walk, ride bikes, visit neighbors, look at nature, etc. If we can keep the automobile speeds under control by awareness and discipline, drastic measures will not need to be considered.

Hey everyone! I really hate to make this post due to the



horses have made sooo Running thru the sprinklers many friends out at Gulf Hills, but I have come to notice many people are not following the signs we have posted. We post these signs for your safety and the animals. We do have a **do not feed** sign posted at our front gate by the T-Box due to the fact that one of the horses is as in the equine world its said "insulin resistant" which in our world is pretty much the same as diabetic. We do have him on a very special feed that not only his vet but also his farrier (one who clips and manages their hoofs) has put him on, and he also has special shoes on his feet that will not separate due to the insulin resistance. It will not be fair to him if the rest continues to get treats so as of this time, we do ask that no more treats are given. I will be purchasing some treats that are safe for him to consume due to his health issues. I work a normal 7:30-5:00 schedule but if you would like, we can work something out where you can message me and I can come give you the health safe treats to give to the horses. We're only asking this for his safety. If we cannot work on this, then he will have to have a grazing muzzle placed on him to guarantee his safety which is also not fair. Everyone is still more and welcome to go see and pet them they would really miss all the friends they have made! And I will also add I have been asked multiple times on why "We don't keep hay out there for them?" We try to find it but with how dry these past few months have been all the hay harvest has had issues on hay growing it's just burning in the fields. The last bale they just finished off I got from north Lucedale, MS which is a haul all the way down here. We also must be careful with what is in their hay also due to the insulin issue.

They get feed supplements and support for forage with the grass issue out there and we have eased them into getting used to the sprinklers to help get the grass to start coming up also!

# **Gulf Hills Civic Association Information Distribution**

In an extreme effort to distribute and share information to Gulf Hills residents, the Gulf Hills Civic Association has established several avenues to stay connected. The traditional and long-standing effort of quarterly newsletters allows hard copies to be mailed to each household but is not published often enough to keep abreast of our fast moving world. With the advent of email and social media, we have embraced the use of Yahoo and Facebook Groups to provide more immediate and interactive information. This year, our website, Gulfhills.org was developed to present a positive, one-stop place for all of Gulf Hills to be in display to the world. Recently, we have started using a direct email list to provide information to those not yet ready to venture into the Facebook community. Listed below is the information distribution strategy that the GHCA Board of Directors will follow in using these options. Choose one or all and stay connected as you are interested. If nothing else and if you have internet capabilities, go to Gulfhills.org and sign up for email alerts from postings through that site.

**Gulf Hills News** – non-timely information that reaches all households and stored on Gulfhills.org

**Gulfhills.org** ----vetted information encompassing all aspects of Gulf Hills, including the amenities found within our community. Announcements of events will come after final planning is made.

**Gulf Hills Civic Association Facebook Group** – information used to facilitate the civic association organization, including the development of programs and committees. Events will be discussed and supported in this venue. Membership is open to annual fee-paying members of the GHCA.

**Gulf Hills Living Facebook Group** – venue supports an open, but moderated, posting and discussion of issues that are important to individual residents, neighborhoods, and the community at large. Events in Gulf Hills that have been fully developed will be publicized in this group. Additionally, Gulf Hills Living allows for synergy among residents to create a quick response to community needs. Membership is open to any resident of Gulf Hills and may include particular associates and family of residents.

**Gulf Hills Yahoo Group** – an email group is open to any Gulf Hills resident. Information sent to the general residency of Gulf Hills via electronic media will also be sent to this group. Open, but moderated, discussion is performed via email postings. Events will be pushed to this group via the Gulfhills.org website event postings.

**Direct email group** – Any information sent to the general Gulf Hills residency will be sent to emails of record associated to Gulf Hills residents. The emailing is done via a blind copy and there is no discussion within the emailing event. Events will be pushed to this group via the Gulfhills.org website event postings.

Gulf Hills News is published four times each year, delivering via first class mail to more than 420 residents in our community. This effort has been mostly undertaken by one long serving GHCA Director, Van Arnold. While there are a variety of contributors for articles throughout the year, the work of design, ad sales, editing, etc. consumes a lot of personal time. As we are now starting work on the third publication in 2020, we will be formalizing the use of an editor, ad sales, and distribution team. # Memorandum of Understanding to the Jackson County Planning Department and Commission

#### May 19<sup>th</sup>, 2020

Jackson County Planning Commission

On behalf of the Board of Directors, representing the Gulf Hills Civic Association, I present the following thoughts on moving forward with the redevelopment of the Gulf Hills Golf Club land in the return to a profitable golf course and surrounding amenities.

The Gulf Hills Golf Club land is within and zoned the same as the surrounding homes, a R1-single family residential area. It is to be understood and taken into consideration that the Gulf Hills Golf Club was duly sold to Don and Reagan Pfeiffer by required majority vote of the corporation share-holders, it's property, assets, and liabilities. Deed restrictions were included that requires maintaining a working nine-hole golf course within the existing property for a minimum of ten years. We acknowledge that the Pfeiffers have the rights to develop or sell land that is not to be used for the golf course business. However, they have committed to bringing quality homes and significant green spaces that will help protect home values and lifestyles. This development must follow Jackson County regulations, restrictions, and approval processes.

As this development is a difficult change for some adjacent homeowners, we foresee that the return to a profitable golf course and the eventual resort-like business is best for the Gulf Hills Community. Recent input from our residents showed that most are okay with the needed development to occur as it brings the golf course back to life. Others have deep concerns of how it will affect their homes and daily lives. Still, some would like to see a total plan of the development before forming an opinion. The Jackson County Planning Department and Commission have the responsibility to manage the change process that the golf course properties will follow as development occurs. The Gulf Hills Civic Association request that you keep us informed of the applications, progress, and delays as we proceed from this date and look forward to details of the full plan.

We expect that challenges will be seen in drainage, utilities, and increased traffic. For a period of time, there will be increased road activity from contractors, but there will be a significant increase in ongoing vehicular traffic in areas of multiple lot creations, then feeding into the main thoroughfares of Shore and Ridge Roads. Already existing drainage problems should be considered in the permitting of any new construction on any lot in Gulf Hills. As utility connections are made, roads will be disturbed. The Gulf Hills Civic Association will be moving ahead with requests for help in control of excessive speeding, littering, incorrect drainage, crime prevention, and road maintenance. Each of these are important to our residents as we move into a new phase of Gulf Hills history. Respectfully submitted,

Residents may be sad to see that some of the old azaleas were removed. The maintenance crew attempted to save



Photo credit: FredLSalinas them from the weeds and trees that had over- taken them, but the effort was not successful. Once the roots have been cleaned up, plans are to replant them. Meanwhile, the golf course has undertaken to improve several areas connected to and associated with the course. We have already seen the cleaning, pruning, and mulching of crepe myrtles along the streets. Their attention is now turning to two areas of common ground. They are partnering with AT&T to improve the communications sub-station at the corner of Pine and Ridge roads. The equipment was placed on a platform after Katrina and the surrounding area left to neglect. The golf course will also continue their partnership with the Gulf Hills Civic Association and the Gulf Hills Hotel and Resort to improve the conditions and provide continued upkeep of the south entrance sign, plantings, and grassy area.

## Gulf Hills Hotel Hurricane Information Donna Brown, GM, Gulf Hills Hotel

Gulf Hills Hotel is pleased to offer accommodations to you and yours in the event of a storm bearing down. We extend the special Resident Rate throughout the year. We



honor this as an Evacuation Rate before, during and after a major storm. The hotel has been a "Safe Harbor" for many Gulf Hills neighbors in the past. It must be stated – Gulf Hills Hotel is NOT a Hurricane Shelter. We are NOT a Red Cross Shelter. You will be asked to sign a waiver releasing Gulf Hills Hotel of any liability associated with a pending storm before, during and after. Katrina changed a lot of things and lives 15 years. Katrina changed the way we are now able to offer our services. COVID-19 is now changing the way we also operate today. If you are experiencing ANY symptoms or have been in contact with anyone with COVID- 19 in the past 14 days, please do not come. We reserve the right to do daily contactless temperature checks. Personal masks and appropriate physical distancing are requested please.

1. If a storm ENTERS the Gulf anywhere as a Cat 2 or above – we CANNOT accept any guests. Those guests who might already be in the hotel will have to vacate.

2. We will accept guests for Tropical Depressions, Tropical Storms and Cat 1 ENTERING the Gulf and remaining as a Cat 1 or less. If a storm is in the Gulf and grows to a Cat 2 within 12 - 72 hours of reaching landfall, those guests who might already be in the hotel will have to vacate.

3. We do allow you to bring your inside family pet(s)– housetrained dog and cats only – maximum 2 per

room. You must let us know in advance that you will have the pet with you. We also ask that you bring a crate or pet carrier with you. We assign rooms based on this information. The pets must be on a veterinary prescribed flea and tick prevention medicine. We will need verification of this.

Gulf Hills Hotel does not have a back-up generator system. If the power fails, we will be without. That means no lights, A/C, phone or TV. We do not have a full service restaurant on property. We do serve an extensive continental breakfast to all guests. We make every effort to provision adequately for our breakfast needs. All guests who do check-in during storm times are asked to bring the following for their personal use: Battery powered or LED flashlights or lanterns. (Open flame candles ARE NOT PERMIT-TED in any of the sleeping rooms.) 1 gallon of water per person. Personal medicines. Snacks ,food and drink for your family in appropriate ice chest(s) and containers. 3 days' worth is usually the norm.

We cannot gather together as a group for meals, etc., due to COVID-19. We have a couple propane gas grills and we keep four 5 gallon tanks filled for these times. We are a small staff (and a much older staff!) and we cannot do it all. We will try our very best to provide traditional hotel housekeeping services however due to COVID-19 we are currently NOT offering service between check in and checkout. We are disinfecting and sanitizing as required by CDC and then some. Again, this depends solely on the power (or not) and the staff on hand. Everyone's safety ,security and health is our primary focus. We will do our very best to accommodate everyone's needs to the best of our ability. HERE'S PRAYING THAT OUR GULF COAST WILL BE SPARED THIS 2020 SEASON!



# **Complaints to the Jackson County Planning Department**

Concerned about what's going on in your neighborhood with construction or hazardous situations? There is a way to address the concern with the Jackson County Planning Department. They accept requests to perform an inspection



against a possible code violation. An individual resident can make this request or the Gulf Hills Civic Association can make the contact on your behalf.

These inspections are designed to make sure that activity occurring at any location in the county is being performed per the building and zoning codes. If a violation is determined, the owner of the property may be given specific instructions for actions required before moving to an official citation. These situations are separate from requests by residents on variances to zoning changes and is not the path for concerns of development on already zoned property within those zone restrictions.

# **Garbage Pickup Reminder**

Household garbage pickup is scheduled each Tuesday. On **THREE** major holidays (New Years, Thanksgiving, Christmas) pickup will be postponed a day. Check the holiday schedule in the newspaper or on TV.

# **Rubbish Reminder**

Rubbish (no-household garbage) pickup is scheduled for the second week of every month and all limbs and debris need to be put out by 7:00 am Monday of that week.

#### Limitations of Rubbish Pick-Up

The maximum volume of trash, trees, debris and/or vegetation that Jackson County may remove per pick-up per month is 3 cubic yards.
