This summer, long time Director and President of the Board, Dave Philo, retired from his formal civic duties and resigned from his leadership of our Gulf Hills Civic Association. Please join me in thanking Dave for his commitment to our neighborhood. He was always ready to give of his time and talents. The Board of Directors have put their trust in me to fill his chair and move forward in the work of the Board. Thirty years ago, Donna and I had been in our newly built house on the northeast corner of Corto and Mesa for almost one year; Billy and Penny Davis were starting their house on the opposite



corner; Mesa, Plano, and Orchard roads would soon be fully developed, and the future was in front of us. Now, living in the future as grandparents, we often reflect on how Gulf Hills has gone through many changes and challenges. With a diversity of talented, energetic neighbors, our community has thrived with amenities in close proximity, good utilities, and roads.

Within the confines of Gulf Hills are several amenities we have come to appreciate and expect over the years. Each of these them play a part in making Gulf Hills a desirable place to live. Articles on the current status of the hotel, golf course, racquet club, and the new *Sandtrap Grill* are included in this edition of Gulf Hills News.

It is with all earnestness that I appeal to fellow residents to do what they can to support each of these amenities, all private businesses, but they are certainly tied to our community. Of particular need is an increase in support for the Golf Course. They are on a rebound from a couple of unfortunate years. I am certain that most of us would not want our community golf course to go the way of several on the Gulf Coast and others throughout the country. These situations are highlighted in a June 5th Wall Street Journal article on failing neighborhood golf courses. Unlike the golf course in the lead story, the Gulf Hills Golf Course has already been purchased by residents and friends. We just have to keep it going. There are many ways we can help the golf course through this short-term challenge. While they would certainly take a cash donation at the club house, they have offered a nice gift certificate of 3 rounds (with cart) for \$100.00. Take a look at their membership schedule and the other related articles for more information on the golf course status and how you can help.

While change is inevitable, accepting a certain outcome is not. As residents, we can make a difference with our patronage and support of our "built in" amenities. We can make a difference with our collective efforts to improve our neighborhood.

Gulf Hills Golf Course — Status Check-In

Our neighborhood golf course is the second oldest on the Mississippi Gulf Coast, dating back to 1927. Only the Great Southern Course, on the beach in Gulfport, is older. The Gulf Hills Golf Club has managed our home course since 1998, having brought residents and community-minded citizens together to purchase the course that year from a Taiwanese corporation. Recently, residents have been concerned with the health of the course, both physically and financially. To summarize, here are a few points:

The Fiscal Year of 2019 (Aug2018-Jul2019) was a rebuilding year with several specific challenges. While Jimmy Fayard returned to manage the facilities and put the course into a tournament ready state (particularly the greens), extensive rains and harmful wildlife gave extra work to the grounds' crew and deterred reasonable play. Income wise, every golf course looks at maximizing the rounds played and paid in a year. For the Gulf Hills course, this was a challenge while the course condition improved and rounds of golf dropped below the acceptable minimum.

Although now improving, the big climb is in both the course condition and the confidence of the area golfers. While Jimmy Fayard improves the course, George Canaga is actively leading a Gulf Hills Golf Course marketing committee to identify and put into place new strategies to reach the golfing community, individuals and tournaments. This committee is of a diverse background from our community, giving their time and talents to highlight one of our biggest assets.

So now that you're asking "why should I be a paid member?" Let's look at a few interesting points for clarification.

The Gulf Hills Civic Association (GHCA) is not an HOA; we are a 501(c)3non-profit organization chartered with the State of Mississippi.

- The Association is managed by 12 Directors, elected 4 each year from the membership for a 3-year term.
- The GHCA Board of Directors elect officers at its April meeting.
- The GHCA represents all residents of Gulf Hills and businesses associated with this community, as needed, to government and utility interests.
- The GHCA partners with other community entities, such as the Gulf Hills Hotel, Gulf Hills Golf Club, Gulf Hills Racquet Club, and Gulf Hills Garden club to maintain what is desired and improve what is needed.
- The annual membership meeting attendance and voting are allowed only to paid members. Whereas all Gulf Hills residents are represented by charter, only annually paid residents and associates are members of the GHCA.
- Membership is for each household, and each household receives one vote at the annual meeting for whatever action comes before the general membership.

A question was recently asked concerning what authority does the GHCA and/or its Directors have in the community. Authority? None. Influence, yes. The Jackson County Board of Supervisors, Planning Commission,

October 1st starts our annual membership West JC Utility Authority, and other entities campaign for 2020. If you would like to catch look to the Civic Association for guidance on things that matter to the Gulf Hills community.

The GHCA annual budget includes the publication and distribution of 4 quarterly community newsletters; maintenance of 2 trail cameras on the Memorial Gardens; an allocation toward payment of utilities for the Memorial Gardens; annual lease payment on the state land used for the community sign at the south entrance; costs of the annual membership meeting, community cleanup, community yard sale, Christmas Decorations contest; and appropriate support for our local first responders and West Jackson County government workers.

As we move into 2020, I urge you to become a full member of our community by being active in you Civic Association not just as a paid household membership; but as a participant in the activities of the association: as a member of working committees; by promoting our neighborhood and its amenities; and by speaking openly with your neighbors about your concerns for our neighborhoods. So, why become a member? Simply put, it is funding the programs and becoming more of an influence on the direction and plans of our community.



Successful Yard Sales generally require some thought and pre-planning. Be sure to have price stickers on most items and have lots of change and small bills. It's not unusual for someone to pull out a \$100 bill to pay for a \$2.50 item.

YARD SALE TIPS

<u>Be an early bird</u>: Get started by 8:00, as yard sale customers like to start early to get the best deals.

<u>Be visible</u>: Join together with a pal who has a visible, accessible home—Shore Dr., of course, is ideal. More stuff attracts more customers—another good reason for friends to sell together.

<u>Signage</u>: If you don't live on Shore Dr., put up signs at intersections directing customers to your home. Set out a sign on your lawn that advertises what you have for sale, for example, tools, clothes, books, and so on.

<u>*Mark items:*</u> Have your prices clearly marked or tagged, but be prepared to negotiate. This is part of the fun for many yard sale customers, so try to be flexible!

<u>Have cash ready</u>: It's a good idea to have ones, fives and tens handy in order to give change in case a customer wants to pay with a large bill. Don't leave your money unattended, of course.

<u>Insist on cash</u>: Accept checks only from someone you know.

<u>Organize your items</u>: Try bagging small, single items that you want to sell together—such as children's blocks--in clear plastic bags.

•Jimmy Fayard is now the course custodian. Since his return last fall, a remarkable transformation has occurred.

•There has been direct correspondence and email with golfing groups to encourage their continued patronage.

•New course publicity has been distributed to popular areas of patronage by golfers.

•Course stockholders were solicited for individual contributions and have responded with donations to help with the near-term budget.

•Visits to managers of commercial venues to have them encourage guests and visitors to utilize the course.

•The Course Management team is an all-volunteer unit, thus maintaining payroll only at the level needed for proper course maintenance.

•A monthly bank withdrawal system has been developed to facilitate the payment of member dues.

•Utilization of the Carlisle House next door to the clubhouse for non-golfer events.

•More frequent use of the social media

•A marketing committee meets regularly to consider the effectiveness of current initiatives and look for new possibilities.

It was then that he learned that in addition to the money, he should form a corporation with a CEO and Board of Directors, then locate interested parties to purchase shares of stock in the newly formed corporation.

Soon after, meetings were held with residents of the Gulf Hills community and other interested parties. At one of these meetings, Arnold set-out a "vellow tablet" and asked attendees to pledge their support, if willing, to purchase stock at \$5000/ share with a maximum of ten shares. He then ad-

Recently, a Facebook discussion thread was started by a new resident wondering if Gulf Hills did Trick or Treating. The responses were varied, as is typical of any discussion about Gulf Hills. While some regretted that they never get a Halloween participant, others said they get some visitors, yet some like to go to downtown Ocean Springs where they can maximize their treats to steps ratio. Rubbish Reminder

Rubbish (no-household garbage) pickup is scheduled for the second week of every month and all limbs and debris need to be put out by 7:00 am Monday of that week.

Use the landfills whenever possible -- especially during the dry spells in an effort to prevent fire hazards -- Plus the Seaman Landfill is free to residents!

Limitations of Rubbish Pick-Up

The maximum volume of trash, trees, debris and/or vegetation that Jackson County may remove per pick-up per month is 3 cubic yards.

Household garbage pickup is scheduled each Tuesday. On **THREE** major holidays (New Years, Thanksgiving, Christmas) pickup will be postponed a day. Check the holiday schedule in the newspaper or on TV.

Lighting District Reminder

Gulf Hills Lighting Commissioners, ask that you report outages or malfunctioning streetlights to Mississippi Power at 800-487-3275. Give the address closest to the light. The District is being charged for each light, working or not.
