MISSION

To promote and encourage the development of the residential area known as Gulf Hills, in Jackson County, Mississippi, for the best interests of the present and future residents of such area; to encourage among the members closer personal acquaintance and a friendly spirit of mutual cooperation; to acquire, maintain and operate equipment and vehicles for the prevention of fires, or the extinguishing thereof, in Gulf Hills and adjacent property, or to contract for such services; and generally, to do and perform all other acts incidental or necessary to the operation of a community civic association.

The GHCA is governed by a Board of Directors, elected by the membership at the Association's annual membership meeting, which is held in March each year. Any member in good standing can be selected to serve as a Director. The Board also meets monthly to address any business items.

WHAT WE DO

The GHCA serves the Gulf Hills neighborhood in many ways.

- Neighborhood Events. The GHCA hosts or organizes a variety of neighborhood events, including Halloween in the Hills, Christmas in the Hills (and the included Deck the Hills home decoration contest), an annual neighborhood yard sale and neighborhood cleanup. We are continually looking for other opportunities to bring our neighbors together!
- Communications. The GHCA prepares and publishes a quarterly newsletter, which is mailed to each known household within the Gulf Hills neighborhood. The newsletter contains updates, important contact information and local news of interest. Additionally, the GHCA has established a website www.gulfhills.org to serve as a resource for neighborhood residents for upcoming events and other items of general interest, and a social media presence on Facebook to provide further outreach specifically to members.
- Engagement with County and Public Officials. The GHCA has established and maintains a working relationship with public officials, including the county and utility district, allowing the GHCA to receive updates and in turn keep members informed of developments impacting or affecting the neighborhood and its residents. The GHCA can also serve as a conduit for expressing concerns of its members to these officials.
- Memorial Garden Maintenance and Upkeep. The GHCA has assumed full responsibility for the maintenance and upkeep of the Memorial Garden located at the intersection of Ridge Rd. and Shore Drive. This beautiful garden can be enjoyed by all residents and is the site of various neighborhoodwide events.
- Safety and Security. The safety and security of the residents of Gulf Hills are a priority for the GHCA. The GHCA is active on many levels to increase the livability of our neighborhood, from street lighting and visibility, to increased law enforcement presence, to providing safety tips for pedestrians, bicyclists and operation of golf carts. The GHCA was instrumental in forming the Gulf Hills Lighting District, which pays for and monitors the LED street lights in the neighborhood. The GHCA continues to seek input from our neighbors and to develop new ideas for preserving the safe enjoyment of our community.

HOW CAN YOU GET INVOLVED?

Join the Association if you have not already! The GHCA cannot operate without support from the neighbors we serve. All the activities engaged in by the GHCA require funding. Membership dues are currently the main source of revenue for the GHCA. For the GHCA to continue to grow, we must have members! Dues for 2022 are only \$30 per household!

Volunteer to serve on committees! There are a number of ways for members to participate in the work of the GHCA. The GHCA is a wide and varied organization, and our members have unique abilities and skills. The GHCA has a number of working committees - our bylaws contain a complete list. If there isn't a committee that interests you, make a suggestion and volunteer to help! Contact a Director if you want to discuss serving on a committee or come to our Annual Meeting March 15, 2022 and sign up!

Attend the Annual Membership Meeting and Monthly Board Meetings! Although we maintain year-round communication, the annual meeting is your formal opportunity to come hear a report on the state of the GHCA, the activities of the year, plans for upcoming year and take action on business items. Members of the Board of Directors are also elected during the Annual Meeting.

Civic Associations and Home Owners Associations

Different organizations for different purposes

Many prospective residents to Gulf Hills have sent a case in Gulf Hills, many of our residents could live email even asked if a particular property was in arrears for their monthly dues. Recently, the developer of the new subdivision within our subdivision, The Greens at Gulf Hills, has suggested that an HOA will be in place for those particular home owners. Hence, the need for this short summary of the differences of HOAs and civic associations.

Basic Design/Purpose

CA – formed and driven by citizens within a geographical area to improve the life of residents, including working as a collective body with the appropriate governmental entities.

HOA – set up by developers of a specific housing sub-division of land to give residents a process to maintain adherence to the designed covenants and manage needed changes in the subdivision after the developer has completed their construc-

Membership/Funding

CA - membership is voluntary and so are the fees. Joining a civic association is driven by civic duty, desire to help in the collective effort of maintaining a particular lifestyle if not an improvement

HOA – membership is mandatory and per home and so are the fees, paid yearly or monthly. HOAs are desired by many homeowners as it provides extra guarantees for the "status quo" of look and activity in the community.

Grievance Process/New Norms

CA – the association helps residents resolve issues with neighbors' activities and variances against building codes by lending the collective voice to the government entities. Likewise, improvements are considered through the association's directors, then moved to government entities or put into action as appropriate.

HOA (a pseudo-governmental entity) – residents bring their problems directly to the HOA elected directors for a ruling against the subdivision plan and designed covenants. The HOA has legal control of the outcome. Any new need of the community can be deliberated among HOA directors and within the community with an outcome that is voted on and implemented. Implementation could result in an increase in HOA fees, essentially, an increase in tax.

Can a civic association represent residents that exist within an HOA? As might become the

emails inquiring as to our monthly HOA fees. One I in a home that is governed by the standards of an HOA. This does not preclude the voluntary membership of any of those residents in the Gulf Hills Civic Association. These are two associations with separate missions. However, the HOA directors could, on behalf of its association, work separately or in conjunction with the GHCA in solving problems or asking for improvements when addressing the county government boards and commissions.

We will start this year's meeting with a time of social interaction, starting at 5:30 p.m. with refreshments provided by the association. Our business meeting will start at 6:30 p.m. and last no more than one hour. Items on the agenda include:

ACEND

 treasurer's report of expenses in 2021 and the proposed budget for 2022;

- a review of events since our last membership meeting;
- a look at the Gulfhills.org website;
- a discussion of opportunities in the Gulf Hills community and civic association.

There will be several items which require a vote of the Members.

- The first is the election of 4 Directors to fill terms ending in 2022. The Board will present a slate, however, nominations from the floor will be accepted.
- 2. The second is proposed changes to the bylaws of the Association. A copy of the by-law proposal to Article IX is included in this publication. The Board is recommending reducing

the number of standing committees, currently standing at twelve (12) and condensing responsibilities into six (6). The new proposed committees are: Membership, Community Infrastructure, Publicity/Communications, Community Safety, Memorial Garden and Events.

 The final action item is the ratification of membership dues to begin in the 2023 membership year. The Board is recommending an increase from the current \$30 to \$50/ year.

Bridge Coming to Gulf Hills

Raegan Pfeiffer, part owner of the Gulf Hills Golf Club and member of the Gulf Hills Civic Association, notified the Civic Association of a significant settlement in Shore Drive where the road goes over culverts draining to the canal behind the Memorial Garden. Many drivers in Gulf Hills headed West on Shore Drive have been swerving out of their lane to avoid that depression. This is dangerous because cars coming toward them in the other lane are hard to see due to the curve there. The depression is due to washouts around the culverts under the road. The County has just been dumping asphalt there, but it keeps subsiding. Joe O'Neal, with the Jackson County Road Department, came out to look at the road

with me. He decided that it was time to replace the culverts with a bridge. This will require routing the overhead electrical power lines away from the road there. He said that it would take 5 months or



so to design the new bridge, and that he would get the drawings to us to review. To date, the County surveyors have been to the site and surveyed the roads and the canal. The drawings should be completed by May. Shore Drive will be closed at the Memorial Garden during construction of the bridge, but drivers can still get to and from Washington Avenue on Ridge Road.

Rubbish (no-household garbage) pickup is scheduled for the second week of every month and all limbs and debris need to be put out by 7:00 am Monday of that week.

Limitations of Rubbish Pick-Up

The maximum volume of trash, trees, debris and/or vegetation that Jackson County may remove per pickup per month is 3 cubic yards.
